

6. Subject to the control of the Board of Trustees, The Board of Trustees shall be sole incharge of the entire functions of board of Trustees and shall act on behalf of and in the name of Trust with out prejudice to the general authority granted to Board of Trustees. The Board of Trustee shall maintain or cause to be maintained all accounts of trust, incur expenditure for the administration and / or properties of the trust and take all action legal or other proceedings before any court of authority whatsoever in the name of the trust as may be decided by the Board of the Trustees from time to time. The Board of Trustee shall execute, implement decisions of the Board. The Board of Trustees shall appoint staffs for administration of the trust and / or trust property on such terms as he decides and shall have the power to dismiss a person so appointed.
7. The Trustees shall maintain the accounts of the Trust regularly and close the account every year by 31st March and the same shall be audited by a qualified *Chartered Accountant*.
8. *The Trustees may accept* any donation or contribution in cash or in kind from any person, firm, company, corporation, associations, institution or trust (including the trustees or any of them) for the furtherance of the objects of the trust.
9. The trustees may invest the trust if acquired in future either in the purchase of immovable properties or of mortgage immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary and dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to Sub. Sec. (3) of Sec.13 of Income Tax act 1961 or any subsequent amendments as may be made from time to time.
10. All the trustees unless they voluntarily resign or otherwise decide, shall continue to be trustees during the term of their natural lives.
11. If the income of trust in a particular year is not fully utilised, the unexpended income object to the applicable provisions of the Income Tax Act, 1961, shall be carried over the next year(s) and spent in such subsequent year(s) for any of the objects of the trust.
12. The FOUNDER CUM CHAIRMAN and trustees open and keep an account (s) with any bank(s), and operate such account(s) in the name of Trust.

The board of trustees shall have full power to compromise or compound all actions, suits, and other proceedings and settle differences and disputes touching the Trust Estate and / or the Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and / or the Trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bon'a-fid'e loss occasioned thereby.
14. Fifty-five percentages (55%) at a meeting shall form a quorum for any meeting of the trustees.
15. In case of difference of opinion between the trustees the opinion of the majority shall prevail and if the trustees are equally divided in any matter, the Chairman shall have a Casting vote.
16. A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be as valid and effectual as if it had been passed at a meeting of the trustees duly called and convened.
17. No person being –
 - (i). an undischarged insolvent, or
 - (ii). Convicted of an offence involving moral turpitude, or
 - (iii). Of unsound mind, or
 - (iv). A minorshall be eligible to be a trustee.
18. The power to appoint new or additional trustees shall and to fill vacancies in the office of the trustees, shall vest in the continuing trustees.
19. A general body meeting of the trust shall be convened once in a year, at which the trust hereby constituted and Audit report by a qualified Chartered Accountant shall be considered.
20. The trustees shall invest the fund only in accordance with the provisions of section 13 (1) (d) read with section 11 (5) of the Income Tax Act, 1961.
21. This trust is irrevocable.





